### 5. Fire Department Constitution and By-Laws

# 6. Street Lights

Wohlert moved and Davidson seconded to approve the request from Hansen Family Hospital to move forward to get street lights placed along South Oak Street in the area of their facility.

### 7. **Downtown Building Lighting**

Nissly moved and Messa seconded to approve Resolution No. 2015-01 authorizing the submission of a grant to Hardin County Community Endowment Foundation for \$10,000 with a \$10,000 match from the Streetscape Fund with the funds to be used for building rooftop LED lights, season banners for the new light poles, lighted holiday light post decorations and a clock if funds are available.

### 8. City Hall Building

### 9. Hardin County Sanitary Solid Waste Disposal Commission

Messa moved and Wohlert seconded to approve Resolution No. 2015-02 for appointment of a representative and alternate representative to serve on the Hardin County Sanitary Solid Waste Disposal Commission.

# 10. Hotel/Motel Tax Funding Advisory Committee

- a. Messa moved and Nissly seconded to approve the funding request from Iowa Falls Area Development Corporation in the amount of \$30,000 for the 2015 IFADC Marketing Plan with payments to be made quarterly with the funds coming from economic development funds. Roll Vote: Messa, Nissly, Thies, Wohlert and Davidson voting aye.
- b. Nissly moved and Thies seconded to approve the funding request from Iowa Falls Chamber/Main Street Tourism Committee in the amount of \$20,000 for Fall in Love with Iowa Falls with payments to be made quarterly with the funds coming from tourism funds. Roll Vote: Nissly, Thies, Wohlert, Davidson and Messa voting aye.
- c. Wohlert moved and Thies seconded to approve the funding request from Iowa Falls Signage Committee in the amount of \$11,070 for the replacement of the existing Iowa Falls entrance signs with 50% coming from tourism funds and 50% coming from economic development funds.

d. Nissly moved and Davidson seconded to approve the appointment of Shirley Welden, Monica Olmstead and Vicki Kramer to the Hotel/Motel Tax Advisory Committee for three year terms expiring February 2018.
