APPROVAL OF MINUTES

- d. Gritsch moved and Thies seconded to approve Resolution No. 2020-47 approving and authorizing execution of a FY 2021-2025 Grant Agreement by and between the City of Iowa Falls and Iowa Falls Area Development Corporation. Roll Vote: Gritsch, Thies, Klein, Wohlert and Nissly voting aye.

c. Klein moved and Gritsch seconded to approve the appointment of City Manager Jody Anderson as the ADA Coordinator.

d. Thies moved and Nissly seconded to authorize the Mayor to sign off on the documents.
