# **ACCEPTANCE OF THE AGENDA**

Thies moved and Wohlert seconded to approve the agenda with item #3 being moved before the monthly claims.

### 3. **OEL Overpayment**

The Council discussed the overpayment that was made to OEL on the Washington Avenue resurfacing project. Rob Haaland with Bolton & Menk, reported that they made an error on calculations causing OEL to be paid twice for an item. Council directed Bolton & Menk to contact the contractor and have them try and get the money back from OEL.
