ACCEPTANCE OF THE AGENDA

Klein moved and Nissly seconded to accept the agenda as written.

APPROVAL OF MINUTES

Thies moved and Nissly seconded to approve the minutes of the regular meeting of August 19, 2019, and the special meetings of August 26, 2019 and September 10, 2019.

APPROVAL OF MONTHLY CLAIMS AND FINANCIALS

Nissly moved and Klein seconded to approve the monthly claims and financials. Roll Vote: Nissly, Klein, Wohlert and Thies voting aye.

3. <u>Union Street Project</u>

Klein moved and Nissly seconded to approve Progress Payment #3 in the amount of \$307,113.10 for Gehrke Inc.

4. <u>US 65 Project</u>

Wohlert moved and Thies seconded to approve Change Order 19 in the amount of \$17,960.90 which replaces all the sod with seed.

5. Test Wells

Jenny Ruddy with FOX Engineering presented the rest well results and the recommendation that none of the three test wells appeared to produce the amount of water desired. They will continue to work with IGS to possibly try and find a location closer to the Pine Street wells.

6. Water and Sewer Service Extension

Nissly moved and Thies seconded to direct staff to work with Mitch Holtz, FOX Engineering, to meet with property owners in the area to see if there is any interest in developing housing in this area.

7. North Cadet Trail Project

Thies moved and Wohlert seconded to withhold the \$119,700.72 progress payment and direct staff to contact WHKS Engineers and Heartland Asphalt to let them know that this will not be paid until the water issue on the trail by Rock Run Elementary has been repaired.

- b. Wohlert moved and Thies seconded to authorize the City Manager to have an asbestos inspection and abate that and advertise for bids for the removal of the structure with payment coming from 80% LOST funds.

d. Wohlert moved and Klein seconded to remove the trees and replace them with new ones once the construction is complete.
