63.01 GENERAL. Every driver of a motor vehicle on a street shall drive the same at a careful and prudent speed not greater than nor less than is reasonable and proper, having due regard to the traffic, surface and width of the street and of any other conditions then existing, and no person shall drive a vehicle on any street at a speed greater than will permit said driver to bring it to a stop within the assured clear distance ahead, such driver having the right to assume, however, that all persons using said street will observe the law.

- **63.02 STATE CODE SPEED LIMITS.** The following speed limits are established in Section 321.285 of the Code of Iowa and any speed in excess thereof is unlawful unless specifically designated otherwise in this chapter as a special speed zone.
 - 1. Business District twenty (20) miles per hour.
 - 2. Residence or School District twenty-five (25) miles per hour.
 - 3. Suburban District forty-five (45) miles per hour.
- 63.03 PARKS, CEMETERIES AND PARKING LOTS. A speed in excess of ten (10) miles per hour in any public park, cemetery or parking lot, unless specifically designated otherwise in this chapter, is unlawful. (Ord. 953 Oct. 09 Supp.)

63.04 SPECIAL SPEED RESTRICTIONS. In accordance with requirements of the Iowa State Department of Transportation, or whenever the Council shall determine upon the basis of an engineering and traffic investigation that any speed limit listed in Section 63.02 is greater or less than is reasonable or safe under the conditions found to exist at any intersection or other place or upon any part of the City street system, the Council shall determine and adopt by ordinance such higher or lower speed limit as it deems reasonable and safe at such location. The following special speed zones have been established:

- 1. Special 20 MPH Speed Zones. A speed in excess of twenty (20) miles per hour is unlawful on any of the following designated streets or parts thereof.
 - A. Commencing on Washington Avenue at a point 50 feet west of Main Street and continuing east to the westerly intersection of Washington Avenue and Oak Street;
 - B. (Repealed by Ordinance No. 1057 Oct. 14 Supp.)

- 2. Special 25 MPH Speed Zones. A speed in excess of twenty-five (25) miles per hour is unlawful on any of the following designated streets or parts thereof.
 - A. Commencing on Washington Avenue at a point 100 feet west of River Street and continuing east 845 feet to a point 50 feet west of Main Street;
 - B. On Siloam Road from its intersection with Taylor Avenue to a point 150 feet west of the intersection with Hidden Valley Drive;
 - C. On Georgetown Road from its intersection with Washington Avenue on the north to the south City limits on the south (the north-south portion only);
 - D. On Brooks Road from its intersection with Oak Street west to its intersection with South River Street:
 - E. On Industrial Park Road from its intersection with Oak Street to its intersection with South River Street;
 - F. On Lawler Avenue from its intersection with Brooks Road north to its intersection with Industrial Park Road;
 - G. On Farm View Road from its intersection with Lawler Avenue east to its intersection with Progress Road;
 - H. On Progress Road from its intersection with Farm View Road north to its intersection with Industrial Park Road;
 - I. On South River Street from its intersection with Bliss Boulevard south to its intersection with Industrial Park Road;
 - J. On Cadet Road 100 feet west of Oak Street and continuing west to Taylor Avenue.
 - K. Commencing on US Highway 65 at a point 680' south of Washington Avenue north to 60' north of Iowa Street. (Ord. 1057 Oct. 14 Supp.)
 - L. Commencing on US Highway 65 at a point 60' north of Iowa Street south to a point 680' south of Washington Avenue. (Ord. 1057 Oct. 14 Supp.)
 - M. On Rocksylvania Avenue from Oak Street to Depot Street.

(Ord. 1101 - Jan. 18 Supp.)

- 3. Special 30 MPH Speed Zones. A speed in excess of thirty (30) miles per hour is unlawful on any of the following designated streets or parts thereof.
 - A. Commencing on Washington Avenue at a point 100 feet west of Wilkinson Avenue and continuing east 2,904 feet to a point 100 feet west of River street:
 - B. (Repealed by Ordinance No. 1057 Oct. 14 Supp.)
 - C. (Repealed by Ordinance No. 1057 Oct. 14 Supp.)
 - D. On River Road from Elk Run at the bridge location to the west City limits;
 - E. On South River Street from its intersection with Industrial Park Road south to its intersection with Brooks Road;
 - F. (Repealed by Ordinance No. 1139 Aug. 21 Supp.)
 - G. (Repealed by Ordinance No. 1085 Dec. 16 Supp.)

H. Commencing on US Highway 65 at a point 400' south of the Railroad underpass north to a point 680' south of Washington Avenue.

- I. Commencing on US Highway 65 at a point 60' north of Iowa Street north to a point 25' south of Pierce Street.
- J. Commencing on US Highway 65 at a point 25' south of Pierce Street south to a point 60' north of Iowa Street.
- K. Commencing on US Highway 65 at a point 680' south of Washington Avenue south to a point 400' south of the Railroad underpass.

L. On Rocksylvania Avenue from Depot Street to East 2nd Street.

- 4. Special 35 MPH Speed Zones. A speed in excess of thirty-five (35) miles per hour is unlawful on any of the following designated streets or parts thereof.
 - A. Commencing on Washington Avenue at a point 100 feet west of Slayton Avenue and continuing east 1,901 feet to a point 100 feet west of Wilkinson Avenue;
 - B. (Repealed by Ordinance No. 1057 Oct. 14 Supp.)
 - C. On Siloam Road from a point 150 feet west of its intersection with Hidden Valley Road to the west City limits;
 - D. On Georgetown Road from its intersection with South River Street on the east to the intersection where Georgetown Road runs in a northerly direction;
 - E. On South River Street from its intersection with Brooks Road south to its intersection with Ellsworth Avenue; (Ord. 965 Oct. 09 Supp.)
 - F. On Ellsworth Avenue from its intersection with South Oak Street to its intersection with South River Street. (Ord. 965 Oct. 09 Supp.)
 - G. Commencing on US Highway 65 at a point 1820' north of Greenfield Avenue north to a point 400' south of the Railroad underpass.
 - H. Commencing on US Highway 65 at a point 25' south of Pierce Street north to a point 880' north of North Street.
 - I. Commencing on US Highway 65 at a point 880' north of North Street south to a point 25' south of Pierce Street.
 - J. Commencing on US Highway 65 at a point 400' south of the Railroad underpass south to a point 1820' north of Greenfield Avenue.

- K. On Commercial Street from the north driveway at 1120 Commercial Street south to the intersection with Sherman Street. (Ord. 1139 Aug. 21 Supp.)
- L. On Rocksylvania Avenue from East 2nd Street to East Corporation Road.

5. Special 40 MPH Speed Zones. A speed in excess of forty (40) miles per hour is unlawful on any of the following designated streets or parts thereof.

- B. Commencing on Washington Avenue at its intersection with Slayton Avenue and continuing west to the west corporate limits.
- 6. Special 45 MPH Speed Zones. A speed in excess of forty-five (45) miles per hour is unlawful on any of the following designated streets or parts thereof.
 - A. (Repealed by Ordinance No. 1057 Oct. 14 Supp.)
 - B. Riverside Drive from Oak Street east to the City limits.
 - C. South Avenue 2/10^{ths} of a mile south of South Third Street.
 - D. 140th Street from River Street to JJ Avenue.
 - E. JJ Avenue between 140th Street and 135th Street (Georgetown Road).
 - F. Commencing on US Highway 65 at a point 200' north of Greenfield Avenue north to a point 1820' north of Greenfield Avenue.
 - G. Commencing on US Highway 65 at a point 880' north of North Street north to a point 85' north of Cadet Road.
 - H. Commencing on US Highway 65 at a point 85' north of Cadet Road south to a point 880' north of North Street.
 - I. Commencing on US Highway 65 at a point 1820' north of Greenfield Avenue south to a point 200' north of Greenfield Avenue.

- J. On Cadet Road from its intersection with Oak Street going east to the intersection with Commercial Street. (Ord. 1139 Aug. 21 Supp.)
- K. On Commercial Street from the north driveway at 1120 Commercial Street north to the intersection with Cadet Road. (Ord. 1139 Aug. 21 Supp.)
- 7. Special 50 MPH Speed Zones. A speed in excess of fifty (50) miles per hour is unlawful on any of the following designated streets or parts thereof.
 - A. (Repealed by Ordinance No. 1057 Oct. 14 Supp.)
 - B. (Repealed by Ordinance No. 1057 Oct. 14 Supp.)
 - C. Commencing on US Highway 65 at a point 200' north of Greenfield Avenue heading south to the City limits. (Ord. 1057 Oct. 14 Supp.)
- **63.05 MINIMUM SPEED.** No person shall drive a motor vehicle at such a slow speed as to impede or block the normal and reasonable movement of traffic, except when reduced speed is necessary for safe operation, or in compliance with law.

63.06 CONTROLLED ACCESS FACILITIES. Speed limits on controlled access facilities are as specified in Chapter 140 of this Code of Ordinances.
