# CITY OF IOWA FALLS REGULAR MEETING FEBRUARY 21, 2023

#### **ACCEPTANCE OF THE AGENDA**

Nissly moved and Gritsch seconded to accept the agenda moving item 20 to be discussed after item 7.

### **APPROVAL OF MINUTES**

Klein moved and Cutler seconded to approve the minutes of regular meeting of January 16, 2023 and the special meeting of February 2, 2023.

### 9. **Water and Sewer Rates**

- a. Cutler moved and Nissly seconded to approve on second reading an Ordinance amending the Code of Ordinances of the City of Iowa Falls, Iowa, by amending provisions pertaining to water user rates.

- b. Cutler moved and Nissly seconded to schedule a public hearing on the adoption of the FY2023-2024 Budget for the regular meeting on April 17, 2023. Roll Vote: Cutler, Nissly, Klein, Gritsch and Thies voting aye.

# 13. **Parks Department**

a. Pat Cooley presented his request to raise funds to restore the fireplaces and the south shelter at Foster Park. Cutler moved and Gritsch seconded to allow Cooley to raise funds for the project.

- b. Les Meier presented his request to conduct a pond renovation at Sunnyside Park. Thies moved and Klein seconded to authorize Meier to conduct the pond renovation and to raise funds to complete the project.

- c. Nissly moved and Gritsch seconded to approve the use of the \$23,000 Schiller Grant for the south shelter in Foster Park project.

The Council reviewed the request from Steve Shane to have curb and gutter installed at his house at 901 Depot. Staff will have the engineer look into this.

## 15. **Street Garage**

Thies moved and Cutler seconded to approve the purchase of the new boilers at the Street Garage in the amount of \$32,546.56 with the funds coming from 80% LOST. Roll Vote: Thies, Cutler, Nissly, Klein and Gritsch voting aye.

### 16. **Hometown Reward Funds**

Klein moved and Nissly seconded to approve using up to \$9,000 of the Hometown Rewards Funds for LED lights at the Library.
Roll Vote: Klein, Nissly, Cutler, Thies and Gritsch voting aye.

#### 17. No Parking

- a. Thies moved and Gritsch seconded to approve on first reading an Ordinance amending the Code of Ordinances of the City of Iowa Falls, Iowa, by amending provisions pertaining to no parking regulations.

- b. Klein moved and Cutler seconded to suspend the rules and place on third and final reading.

- c. Thies moved and Nissly seconded to approve on third and final reading Ordinance No. 1178 amending the Code of Ordinances of the City of Iowa Falls, Iowa, by amending provisions pertaining to no parking regulations.
