## Appliance & Tire Disposal Service

1. Starting September, 2008, the City of Iowa Falls started collecting tires and appliances from residents. The service will be available the 1st Thursday of every month.
2. All items for pick up will be required to have the appropriate number and type of stickers attached to the item. Stickers for the disposal of appliances and tires can **only** be purchased at City Hall, 315 Stevens Street, the Iowa Falls Police Department, 321 Stevens Street or by mail. If ordering by mail, send a check payable to the "City of Iowa Falls" to PO Box 698, Iowa Falls, IA 50126; along with your request for the type of sticker needed. Please include a self-addressed stamped envelope with your order. Appliance and Tire stickers **are not** available at Hy-Vee or Fareway.
3. Appliances set out for pick up must be registered with City Hall the Friday prior to the scheduled pick-up date otherwise they **will not** be picked up.
4. Alternative options available to citizens for the disposal of appliances include Hardin County Solid Waste Agency and D & T Recycling. Appliances may be delivered to either site for disposal for a fee. Contact information for:

5. Appliances and tires must be clean of any debris, dirt or garbage.
6. There is no limit to the number of appliances or tires that you set out for collection. The only requirement is that each appliance and tire has the requisite city sticker applied to each item.
7. Items for collection must be placed at the curb no later than 6:30 a.m. on the day of collections. Items may be set out the night prior to the collection day.
8. Tires and appliances must be organized neatly at the curb. Tires that are not neatly organized may not be picked up, regardless if they possess a sticker or not.

## Tires

1. Tires must have a “blue” City of Iowa Falls sticker attached to each tire set out for collection.
2. Tires may be picked up with or without rims for the same price.
3. Tires must be neatly organized in a pile at the curb. Tires left in a mess may not be picked up.
4. The number of stickers required for disposal of tires is dependent of the size of the tire.
5. Cost of one tire sticker is \$5.

<u>Tire Size</u>	<u>Number of Stickers</u>
Bicycles tires (up to 4)	1
Car and small truck	1
Motorecycle, ATV tires	1
Full size truck, SUV	2
Implement tires	3

## Appliances

1. Only approved appliances will be collected. Non-approved appliances will not be collected.
2. Appliances must have a “pink” City of Iowa Falls sticker attached to each appliance set out for collection.
3. Cost for an appliance sticker is \$20.
4. Approved Appliances:

  - Freezer
  - Air conditioner
  - Dishwasher
  - Hot water heater
  - Microwave
  - Washing machine
  - Clothes Dryer
  - Stove
  - Furnace
  - Dehumidifier
  - Trash compactor
